## New York State Legislature and Gov. Kathy Hochul Agree on \$237 Billion 2024-25 State Budget, Includes Hold Harmless Law in Foundation Aid for School Districts

Next steps for Hudson City School District's 2024-25 Budget Process

**April 22, 2024** 

Dear Hudson City School District Community,

On Saturday, April 20, 2024, the New York State Legislature and Governor Kathy Hochul agreed on a \$237 billion budget, which includes School Aid for the 2024-25 school year.

Originally, the Governor proposed considerable cuts to State Foundation Aid, which makes up a significant portion of revenue for all school districts.

The agreed upon budget restores the Hold Harmless law for school districts. This provision states that school districts cannot receive less Foundation Aid from the state than it did in the previous year. By restoring this law, the District will receive the exact same amount of Foundation Aid as it did for the 2023-24 school year (\$17,864,260).

The final state budget also includes a study for Foundation Aid. The Nelson A. Rockefeller Institute of Government of the State University of New York will be conducting a comprehensive study of the Foundation Aid formula. We will continue to monitor developments and will communicate any updates as necessary.

We take our role as the financial stewards of our community very seriously. The District, along with members of the Board of Education, Questar III BOCES, NYSED, and more, worked tirelessly with elected officials to advocate for change. We thank everyone, including our community members, who pushed for change and reduced the impact of the Governor's original plan for School Aid.

## **Next Steps**

Hudson City School District community members will have the opportunity to listen to updates
to the proposed 2024-25 budget over the next few weeks. The Board of Education will receive an
updated 2024-25 budget presentation on Tuesday, April 23, 2024 at 6 p.m. in the Hudson
Junior/Senior High School Auditorium during a special Board of Education meeting.
Additionally, the Board will be voting on the Rensselaer-Columbia-Greene County BOCES
2024-25 budget at the meeting. This meeting can be attended in-person or viewed virtually via

- "Conversations with the Superintendent" sessions featuring budget presentations will be taking place on Monday, May 6, 2024 at the Greenport Community Center, located at 500 Town Hall Drive in Hudson, and on May 16, 2024 at the Hudson City Department of Youth, located at 18 S. 3rd Street in Hudson. As always, these sessions are open to the public and free to attend.
- The May 7, 2024 Board of Education meeting will be highlighted by a public hearing. Community members will vote on the proposed budget on May 21, 2024 from at 11 a.m.-8 p.m. at various polling locations. - Along with the 2024-25 budget, District voters will vote on candidates for two (2) seats to the Board of Education. The terms are three (3) years in length and end on June 30, 2027. Board of Education nominating petitions are due to Hudson City School District Board of Education Clerk Tracy Gaffney on May 1, 2024.
