Home Instruction (Homeschool) Registration

The Hudson City School District has partnered with **Questar III BOCES Home Instruction Services** to support families K-12 who have interest or intent in participating in Home Instruction (Homeschool).

Questar III BOCES will serve as your **primary point of contact** for all Home Instruction documentation, processing, and compliance requirements.

All parents or guardians wishing to enroll a student in the Hudson City School District Home Instruction Program must complete the required online application or submit the required documentation by mail using the process outlined below.

Following these procedures helps ensure that all documentation is received securely and processed in a timely manner while reducing the possibility of misplaced or lost personal information.
